TARC 2015 together with international PhD colloquium and workshop is organized by Department of Accounting, Faculty of Management, University of Lodz, Poland. It is one of the events to celebrate the 70th anniversary of the University of Lodz. The conference is a three-day event, featuring PhD presentations and workshop, keynote speeches, interactive paper sessions and social activities. TARC is a developed continuation of the program of Polish-Lithuanian scientific seminars, which have been organized biannually by University of Lodz and Kaunas University of Technology for 14 years. Its aim is to bring together researchers from different countries to discuss the latest trends and problems in accounting. TARC 2015 will enable participants to focus on current accounting research issues while enjoying the beauty of Lodz and Poland. We are looking forward to warmly welcome all participants from around the world on October 7th-9th 2015.

Topics of the conference

Topics of the conference include, but are not limited to: auditing, accounting education, financial analysis, financial reporting, accounting and governance, accounting and information systems, management accounting, public sector accounting, social and environmental accounting, taxation.

Methodology/perspective of the papers submitted: analytical/modelling, case/field study, empirical archival, experimental, history, interdisciplinary/critical, market based, survey.

Publication

All received papers will be reviewed by international scientific committee (two blind reviews); all accepted papers could be submitted by Authors for fast track publication in an English issue of "Theoretical Journal of Accounting" – "Zeszyty Teoretyczne Rachunkowości" (top accounting journal in Poland) where they will be subject to normal review process.

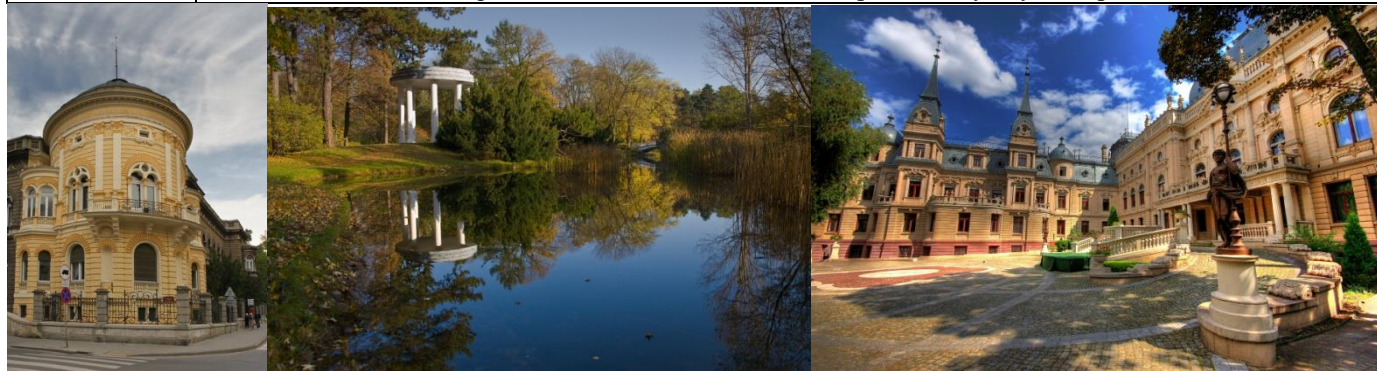
